Article 1: SUBJECT OF THE INVITATION TO TENDER:

The General Manager of the Cameroon Development Corporation launches urgent open international invitation to Tender for the supply of **Agricultural Tools** for CDC Palm Estates.

Article 2: NATURE OF THE SERVICES:

The nature of the services involves the Supply, transportation and handling of the items as specified in the Technical Specifications as per the following Lots:

Lot one: Supply of Harvesting Poles
Lot two: Supply of Agricultural Tools
Lot three: Supply of Formic Acid

Article 3: PARTICIPATION:

This urgent International Tender is open to Enterprises with experience in the supply of these materials.

Article 4: FINANCING:

The Supplies of the above shall be financed by the CDC 2010 Budget.

Article 5: CONSULTATION OF TENDER FILE:

Article 6: ACQUISITION OF TENDER FILE:

Bidders can collect complete tender documents from the General Manager's office (**Room 208**) during working hours (7.30 am to 4pm) Mondays to Fridays as from **25/08/10** upon the payment of a non-refundable sum of **90 Euros (60,000 FCFA)** by Bank transfer to ARMP Special Account No. 335 988 with BICEC. The transfer receipt shall be attached to the file when bidding.

Article 7: PLACE, DATE AND TIME FOR SUBMISSION OF BIDS:

Complete offers written in English or French and in **SEVEN** copies (One **Original** and **Six Copies**) sealed in an envelope shall be deposited at the General Manager's Office on or before the **28/10/10** at **12.00** Local time or by Registered mail to Cameroon Development Corporation. (Bidders should include electronic version of their offer) and samples of harvesting knives and sharpening stones.

The sealed envelope should carry the inscription:

Article 8: TENDER GUARANTEE:

Bidders shall provide a Tender guarantee of **600 Euros (400,000 FCFA)** for **lot one** and **400 Euros (288,000 FCFA)** for **lot two** and **360 Euros (240,000 FCFA)** for **lot three** issued by a Commercial Bank approved by the Ministry of Finance and recognized by **COBAC (COMMISSION BANCAIRE POUR L'AFRIQUE CENTRALE)** for local bidders and by any internationally recognised Bank for bidders outside Cameroon. The Tender guarantee shall have a validity of **120 days** from the date the bids are opened.

Article 9: PLACE, DATE AND TIME FOR OPENING OF BIDS:

The Bid Opening session shall take place at the CDC Staff Club Bota-Limbe on the **28/10/10** at 1 pm local time in the presence of the Bidders or their duly mandated representatives. Only one Representative per bid is allowed.

Article 10: EXECUTION PERIOD:

The duration of execution of the supplies shall not exceed **60** days from the date of notification of the services order to commence.

Article 11: MAIN ELIMINATION CRITERIA:

Bids shall be rejected when:

- They lack proper administrative documents.
- They do not have complete Technical / Financial Offers.
- They do not conform with the Tender documents.
- Samples do not meet technical specifications

Article 12: MAIN QUALIFICATION CRITERIA:

Bidders shall respond clearly by YES or NO to the criteria set below.

The non-respect of any of the above criteria shall result to the elimination of the offer.

Article 13: MAXIMUM NUMBER OF LOTS WHICH A BIDDER CAN WIN:
Bidders can tender for more than one lot and can win more than one.

Article 14: VALIDITY OF OFFERS:

Bidders shall remain committed to their offers for a period of **NINETY Days** from the date of bid opening.
